### **Karrinyup Community Men's Shed - Reopening - Phase 3 Easing of Covid 19 Restrictions**

We are pleased to confirm that further to the Phase 3 easing of Covid 19 restrictions, our shed will re-open on Monday 15<sup>th</sup> June. While everyone will welcome this news, we need to be mindful that the health risks have not gone away. The continued suppression of Covid 19 depends on maintaining our new community norms - physical distancing, good hygiene practices and downloading the COVIDSafe app to keep us all safe.

In keeping with Government directives we have issued our Covid Safety Plan which provides guidance on how our shed will operate until further notice. A copy of this plan is attached for your reference and is also available within our shed for inspection by the relevant authorities. Members are asked to read the plan and adopt its guidelines in order that we can maintain a safe environment for the enjoyment of all.

On the occasion of your their first attendance at the shed all members will undergo a Covid 19 safety briefing, including the completion of an induction process. Members will be required to sign the induction document and comply with all safety instructions.

The KCMS committee has determined that, **commencing from Monday 15<sup>th</sup> June, daily attendance will be limited to 12 persons, plus supervisor inside the workshop and a further 3 persons in the gardens or computer room.**

Until we can ascertain individual demand, attendance will be restricted to one visit per week per member. Accordingly, members are asked to nominate their 1<sup>st</sup> and 2<sup>nd</sup> attendance day preferences by way of **email to [jeffcrookes@iinet.net.au](mailto:jeffcrookes@iinet.net.au) or by text on 0419 903 583.** (Please do not hit reply to this web based email).

Once nominations are received you will receive a confirmation email or text. A roster will then be published at the shed. Members are asked to attend only on their nominated day. Attendance on other than your nominated day may result in refused entry by the duty supervisor.

Although these arrangements may seem a little tedious, they are necessary in the interests of equity, fairness and our community well being. We will continue to review attendance rates and modify rosters as need dictates. Meanwhile, we seek the cooperation and support of members during this phase in period.
